ANNUAL ADMINISTRATIVE REPORT 2021-2022.

Introduction:

The Department of Industries & Commerce is endeavoring to promote Industrialization in the State through various Industrial and commercial activities including Hospitality and Business Service sector in the State.

The task of the Department is, however, a difficult one. The remoteness of the State along with poor industrial infrastructure like road linkages/ electricity were the major problems. The second is the special land laws that restrict the transfer of land to non-locals.

The Government of Nagaland and the Industries & Commerce Department is of the view that the State needs infrastructure led growth and therefore stressing more in the development of infrastructure in the State. The Department has so far created the following infrastructures in order to facilitate the Industrial growth in the State.

- a) Industrial Growth Centre (IGC) at Ganeshnagar, Dimapur.
- b) Export Promotion Industrial Park which is now being up graded to Product Specific Special Economic Zone (SEZ).
- c) Nagaland Tool Room & Training Centre (NTTC) Dimapur aimed with Human Resource Development & Deployment in the Industrial Sector.
- d) Integrated Infrastructure Development Centre (IIDC) at Kiruphema.
- e) Four Industrial Estates (ID) Mokokchung, Mon, Peren & Dimapur during current plan period.

In order to carry out all such tasks, the following are the structures of the Department:

A. *Administrative set up:* The Commissioner & Secretary to the Government of Nagaland **Shri. Kekhrievor Kevichusa, IPoS,** heads the Administrative Department.

- (a) <u>Directorate:</u> A Director heads the Directorate who is assisted by 29 (twenty nine) Officers, 3 (three) Inspectors and 142 Ministerial & Grade-IV Staff. A Construction Wing (Housing Div-VI) attached to the Directorate is headed by an Executive Engineer who is assisted by 3 (three) SDOs, one Divisional Accounts Officer, 3(three) Junior Engineers and seven Sectional Officers to look after all civil works under the Department including PSUs under the control of the Department.
- (b) <u>District Industries Centre (DIC):</u> There are 11 (eleven) full-fledged DICs headed by the General Manager and assisted by Functional Managers & Inspectors and 14 (fourteen) Sub-DICs headed by a Functional Manager and assisted by Inspectors.

During the FY – 2020 under Aatmanirbhar Bharat Abhiyan, the Ministry of Food Processing Industries (MoFPI), GoI, in partnership with the States, has launched an all India Centrally sponsored "PM Formalisation of Micro Food Processing Enterprises Scheme (PM FME Scheme)" for providing financial, technical and business support for new and existing micro food processing enterprises. It is an All India Centrally Sponsored Scheme with an outlay of Rs. 10,000 crore for coverage of 2,00,000 enterprises over 5 years from 2020-21 to 2024-25.

As such, the Department of Industries & Commerce being the State Nodal Agency for implementation of the PM FME Scheme will be providing financial assistance, capacity building, technical and skill development support to existing food processing units, individuals entrepreneurs, SHGs, cooperative societies and FPOs/FPCs to setup/upgrade micro food processing units across all the Districts. Also under the scheme, the Department targets to set up Incubation centres in the Districts and provide seed capital money to SHG members.

4. REGISTRATION OF INDUSTRIAL UNITS:

Micro, Small & Medium Enterprises (MSME):

The Micro, Small and Medium Enterprise (MSME) sector is an important pillar of Indian economy as it contributes greatly to the growth of Indian economy with the vast network of around 30 million units creating an employment of about 70 million. The department of Industries & Commerce, Nagaland being the facilitator and promoter for the development of Industrial Enterprises of the state has been leveraging the information (Schemes and Benefits) under MSME Sector to promote entrepreneurs and develop enterprises in the state. While keeping in mind the importance of the roles of MSME sectors, the department in collaboration with the MSME-DI Dimapur has been pro-active in organizing different programmes and disseminating every information received from the Ministry.

REGISTRATION OF INDUSTRIAL UNITS

The Government policies on industrial development as well as on credit facilities were mainly focused on manufacturing units in the small scale sector. And in past decades the lowering of trade barriers across the globe has increased the minimum viable scale of enterprises. The size of the units and the technology employed for various firms to be globally competitive at present is also of a high order. Hence, in keeping with the global practice the central Government through an Act of the Parliament introduced a new system bringing about a paradigm shift from tiny/cottage, small scale and Medium Industry to Micro Small and Medium Enterprises (MSME).

This change nomenclature of MSME gives rise to recognition of services and trade sectors. Accordingly, the system of provisional and permanent registration has been replaced by filing of Entrepreneurs Memorandum (EM-I & EM-II) respectively and the new system was introduced in the department.

The MSMED Act 2006 marked a shift from SSI (Small Scale Industry) approached to SME (Small and Medium Enterprises) approach. Enterprises are classified as Manufacturing and Service Enterprises based on nature of activity of the Enterprises. Manufacturing and Service Enterprises are further classified into Micro, Small and Medium Enterprises on the basis of investment in plant and Machinery/ Equipment. As per MSMED Act 2006, the investment limits of all categories of enterprises are shown below:

Udyam Registration

Classification of MSMEs and Procedure for Registration w.e.f 1st July, 2020.

 $With the Government Notification OM. No. 5/2 (1)/2020-P\&G/Policy Dated 17.07.2020\ Udyam\ Registration has replaced erstwhile EM Part-I\&II/Udyog Aadhaar Memorandum (UAM).$

A detail notification on the changes regarding revision of definition of MSME and process of registration has been brought out Vide Notification No. S.O.2119 (E) dated 26.06.2020. Apart from the

old criteria of categorization of criterion of turnover the differences between manufacturing and services sector has been removed and now both are on the same level of treatment. This new classification and the frame work are expected to bring a new eco-system development of MSME sector in an integrated manner.

The Government has developed a system of facilitation for registration of Udyam Process w.e.f. 1.7.2020 as given below:

- An Enterprise for the purpose of this process will be known as Udyam and its registration process will be known as "Udyam Registration".
- The registration portal is <u>www.udyamregistration.gov.in</u>
- MSME registration process is fully online, paperless without any need to upload any document and based on self-declaration. Only Aadhaar number will be enough for the registration.
- Permanent registration will be given after registration
- After completion of the process of registration, a certificate will be issued online with QR code.
- PAN & GSTIN would be mandatory from 01.04.2021
- PAN & GST linked details about investment and turnover of enterprise will be taken automatically from Government Data base.
- No enterprise shall file more than one Udyam registration. However, any number of activities including manufacturing or service or both may be specified or added in one registration.
- Erstwhile EM-II or UAM registration or any other registration issued by any authority under the ministry of MSME, will have to migrate to Udyam Registration Portal or file Udyam Registration afresh.

- Single Window System at Champions control room at MSME DIs and DICs will act as facilitator in the process.
- There will be no need of renewal of registration. Registration process is totally free.

At present, total MSME Udyam Registration in Nagaland stands at 3244 of which Micro sector is 3177, Small sector is 61 and Medium sector is 6. Dimapur district has the highest registration followed by Kohima district. With the ongoing sensitization programme in all the districts for *the existing EM-I & II and UAM registered units to migrate to the new system of Udyam Registration*, The registration is expected to grow even more.

Addition of activities (NIC Code) under MSMED Act 2006 for Udyam registration-Retail & Wholesale Trade.

As per the Ministry's O.M No.UAM/MC/01/2017-SME dated 27.06.2017 certain activities were not covered under MSMED Act 2006 and hence not permitted for registration on UAM portal. However, with the OM. No. 5/2/(2)/2021-E/P&G/Policy (E-19025) Dated 02/07/2021, the list of eligible additional activities under NIC code 45, 46, & 47 have been considered as MSME and granted permission to be registered in Udyam Registration portal with the benefits to be restricted to priority sector lending only. And, consequent upon changes, OM. NO. 5/2/(1)/2020/E-P&G/Policy Dated 10/12/2020 stands omitted.

6. STATE INDUSTRIAL POLICY-2000 (REVISED 2004)

Introduction:

The State Industrial Policy-2000 was revised in 2004 in order to provide better facilities to entrepreneurs/industrialists for promotion enterprises both in manufacturing and service sectors. Some of the main objectives of the Policy are (i) To create conditions for rapid industrial development and conducive investment climate; (ii) Create gainful employment opportunities for local population; (iii) Develop human resources and bring about improvement in the quality of life by promoting industrial ventures in sectors in which the State has a comparative advantages; (iv) Develop entrepreneurial and other technical skills of the available human resources; (v) Develop industrial infrastructure in selected areas; (vi) Promote Export Oriented Units with a view to exploit the emerging market opportunities in the neighbouring countries; (vii) Provide investor friendly environment by removing procedural bottleneck and legal hurdles; etc. The following are the Incentive Schemes:

- (i) **Power Subsidy:** Subsidy on power tariff @ 30% & 25% given for connected loads upto 1 MW & above 1 MW respectively for a period of 5 yrs. from the date of commercial production subject to a maximum ceiling limit of Rs.2 lakh annually.
- (ii) **Drawal of Power Line:**Cost of drawal of 33/11 KV line to eligible units located outside the <u>notified areas</u> shall be reimbursed for one time only subject to a ceiling of Rs.2 lakh (now as per NEIIPP-2007, anywhere in the State)
- (iii) **Subsidy for Feasibility Study cost:** Subsidy @ 50% of the cost of DPR subject to a ceiling of Rs.1 lakh is eligible for new units with investment in plant & machinery above Rs.25 lakh
- (iv) **Manpower Subsidy:** 25% of the actual wage bill for local tribal employees employed by eligible units for 3 yrs. from the date of entertainment subject to a maximum ceiling of **Rs.1 lakh annually** for those units where the investment in plant & machinery is from Rs.25 lakh, **Rs.2.50 lakh annually** for units where the investment in plant & machinery is from Rs.25 lakh to Rs.100 lakh and **Rs.5 lakh annually** for units where the investment in plant & machinery is above Rs.100 lakh.
- (V) **Subsidy for Quality Control measures:** Cost of laboratory equipment for the purpose of quality control and ISI/BIS/ISO 9000 certification is reimbursed subject to a maximum ceiling of Rs.50,000/- in case of small scale and Rs.1 lakh in case of medium & large units.
- (Vi) **Stamp Duty Exemption:** 50% Stamp duty & Registration fee for securing loans from Financial Institutions including Mortgage of fixed assets are exempted from the Stamp Duty Act for a period of 5 yrs.
- (vii) **Stipendiary Support for EDP:** Rs.500/- p.m. per trainee is provided for 100 youths annually for training period not less than 3 months duration.

It may be mentioned here that the Department has already decided to revise the SIP in accordance with the policies and programmes of the State Government and other line Departments of the State as well as the Central Ministries.

7. PRIME MINISTER'S EMPLOYMENT GENERATION PROGRAMME (PMEGP):

Prime Minister's Employment Generation Programme (PMEGP) is a credit linked central flagship programme. The Ministry of Micro, Small and Medium Enterprises (MSME) administer the PMEGP and is implemented by Khadi and Village Industries Commission (KVIC) at the National level. At the State level, it is being implemented through State KVIC, KVIB, DICs and Banks.

The Scheme focuses on generating self-employment opportunities through Micro-enterprise establishment in the non-farming sector by helping unemployed youth and traditional artisans. For the current Financial Year 2021-2022, the target allotted against District Industries Centres (DICs) was 688(six hundred eighty eight). Selection of beneficiaries was done as per the new guidelines, based on the marks scored on the scoring sheet of the PMEGP e-portal. The required documents of the selected beneficiaries

has been forwarded to the recommended Banks for taking credit decisions. The employment generation under the said scheme during the current financial year 2021-22 is approximately 2054 nos.

A total of 12(twelve) Awareness Camp/ Outreach Programme covering all the districts has been conducted to sensitise prospective artisans and rural and urban unemployed youth to avail the scheme for Continuous and Sustainable employment. Besides, 24 (twenty four) District Level Monitoring Committee Meeting as well as 2(two) Quarterly Bankers Meet has also been conducted to monitor the performance of PMEGP scheme in the State.

8. NAGALAND TOOL ROOM & TRAINING CENTRE (NTTC):

1. SKILL DEVELOPMENT PROGRAMMES:

NTTC is implementing various skill development initiative schemes with the objective to enable a large number of youth to take up industry-relevant skill training that will help them in securing a better livelihood:

a. DDU-GKY (Deen Dayal Upadhaya Grameen Kaushalya Yojana) under Ministry of Rural Development (MoRD), Govt. of India:

Under the DDU-GKY Programme, so far NTTC had trained 723 candidates, 616 are placed in various manufacturing companies/organizations both within and outside the State and 85 are presently undergoing training in various courses.

b. Pradhan Mantri Kaushal Vikas Yojana (PMKVY 3.0 CSCM):

NTTC is allocated to conduct various short term job-oriented skill training programmes under Pradhan Mantri Kaushal Vikas Yojana-Centrally Sponsored Centrally Managed (PMKVY-CSCM) flagship scheme of the Ministry of Skill Development & Entrepreneurship (MSDE) implemented by National Skill Development Corporation (NSDC). Under this programme, NTTC has to provide job oriented/employable skill trainings along with job placement assistance to 400 youths across PAN India.





9. NAGALAND KHADI & VILLAGE INDUSTRIES BOARD, KOHIMA:

The Nagaland Khadi & Village Industries Board is a statutory body constituted by the Government of Nagaland under the Act – (No. 5 of 1978) of Nagaland Legislative Assembly and it started functioning in January 1979. The main function of the Board is to implement the programmes in accordance with the Khadi & Village Industries Commission (KVIC) pattern of assistance from time to time. Thus, the NKVIB is not a profit making organization of its own but to implement the programmes and scheme of KVIC by providing assistance in the form of marginal grant to the beneficiaries/units financed by the banking agencies under PMEGP scheme to promote Khadi & V.I. activities in the State.

As per the provision of the Act, under Chapter V Clause – 25(i) "... <u>the establishment</u> <u>expenditure of the State Board will be the sole responsibility of the State Government</u>. Similarly it may grant subvention compensation irrecoverable debts."

The Khadi & Village Industries Commission had placed entire Training budget allocation for the year 2021-22 to State KVIC Office, Dimapur to conduct EDP Training in the State of Nagaland for those unit financed by financing agency (Bank) under Margin Money Scheme (PMEGP). The KVIC has assigned NKVIB through MDTC Dimapur to conduct EDP Training for PMEGP beneficiaries. Accordingly, during the current year MDTC has conducted EDP training for 33 PMEGP beneficiaries. It may also be stated that the MSME has introduced the online EDP training module which the beneficiaries are now availing the facility.

3) **CAPACITY BUILDING:**

A) The Multi-Disciplinary Training Center at Nagarjan Dimapur has conducted various village Industries training programme under the purview of KVIC year wise budgetary allocation. The KVIC has fixed tentative physical target against MDTC under NKVIB to conduct **2919** trainees during current financial year under various trade course as per the guideline of Directorate of Capacity building, KVIC Mumbai.

5) Khadi Plaza (Haat):

The KVIC has agreed in principle for establishment of a Khadi Plaza (Haat) at Dimapur, where the expenditure will be met by the KVIC and the State Government on the basis of 90:10 ratios in a phased manner. The KVIC and the State Govt. have jointly laid the foundation stone at Agri Expo Site, 4^{th} mile, Dimapur on 23^{rd} February 2010 by the Hon`ble Chief Minister, Nagaland in presence of Hon`ble Chairperson, KVIC and other Govt. and KVIC officials.

The KVIC hass sanctioned Rs. 6.18 crore for the construction of 1st phase including the State share amounting to Rs. 61,80,000/0 and released Rs. 5.56 srore. State Government has released its share of 10% of the total project cost as seed money. The Boaard has released Rs. 6,17,80,000/- to the contractor basing on the work completion certificate and bill submitted by the technical agency i.e. Engineer wing, Directorate of Industries and Commerce Department.

The State Govt. has earmarked Rs. 4.95 crore to complete the 2nd phase construttion under refinancing agency - HUDCO. The construction of the 2nd phase in undergoing by availing the 1st installment from HUDCO.

The Secretary, MSME and officials from Delhi visited the Khadi Plaza construction site at 4th Mile. Dimapur on 04-12-2021 and assure to provide the fund for completion of this project.





Background & Ownership of the Corporation

The Corporation is a Government of Nagaland undertaking, incorporated under the Companies Act, 1956 on March 26, 1970 with the objective to Promote, Develop, Establish and Assist industries in the State.

With an Authorized Capital of Rs.25 Crore, the Paid-up Capital as on 28th Feb 2022 stands at Rs. 23.20 Crore of which equity of Rs. 4.73 Crore and Rs. 18.46 Crore are subscribed by the IDBI and the State Government respectively.

The Management of the Corporation is vested with a Board of Directors and the Managing Director is the Chief Executive Officer.


Recognizing the importance of skill up-gradation and the indispensability of information technology, the Corporation has placed Human Resource Development (HRD) and Digitization high on its agenda.


1. Industrial Estates



MAP of Industrial Estate New Complex


2. Agro & Food Processing Special Export Zone (AFSEZ) at Ganeshnagar

The Government of India (GOI) has taken several initiatives aimed at developing Special Economic Zones in the country in order to promote exports and develop regional infrastructure. In reference to the same, Nagaland Industrial Development Corporation Limited (NIDC) identified Dimapur as the location for the Special Economic Zone and a SEZ was created with the approval from the Ministry of Commerce vide No. F.1/149x2007-SEZ dated July 9, 2009. With a total estimated project cost of Rs.35 Crore, the Project was planned across an area of 125 acres. The Agro & Food Processing SEZ aims to offer a perfect blend of industrial, business and social infrastructure in the midst of lush and green eco-friendly environment incorporating the latest state of the art green technologies.

With the recommendation of the State Government to the Ministry of Commerce, the SEZ was converted to Agro and Food Processing Special Economic Zone, (AFSEZ) taking into account the abundant agro-horticulture resources of the North East Region and to address the problems of post

harvest wastage thereby providing a boost to the horticulture and agricultural activities of the North East States.

It may also be mentioned that a formal approval has been granted by FALTA SEZ, Ministry of Commerce for extension of validity of the AFSEZ, Ganeshnagar up to 02.12.2022 vide No. SEZ/DEV/N-16/2007/2269. Additionally, with the intention of widening the scope of accommodating entrepreneurs from various industries, the Agro and Food Processing Special Economic Zone (AFSEZ) is in the process of being renamed to Nagaland Multi Sector Special Economic Zone (NMSSEZ) and a request letter has also been sent to FALTA SEZ in this respect vide No. NIDC/BD/SEZ-31/18/Vol-III/1170.



3. IIDC Kiruphema, Kohima District

NIDC was the implementation agency for setting up the Integrated Infrastructure Development Centers (IIDCs) at Kiruphema, Kohima District which was approved by the Central Government with the works been executed by the Engineering Wing of the Directorate of Industries & Commerce, Kohima. The IIDC consist of common facility centres along with developed plots. The project is still with the Directorate of Industries & Commerce Department, Kohima.

4. Refinance Schemes

Starting with a Hire Purchase Scheme in 1976-77, NIDC started employment generation assistance under the refinance schemes of the following Government organizations:

- Industrial Development Bank of India (IDBI) since 1978.
- National Scheduled Castes & Scheduled Tribes Finance & Development Corporation (NSTFDC) since 1992-93.
- National Minorities Development & Finance Corporation (NMDFC) in 1997-98.
- National Safai Karamcharis Finance & Development Corporation (NSKFDC) schemes from 2015-16.

NIDC began channeling funds of the National Scheduled Castes and Scheduled Tribes Finance Development Corporation (NSFDC) from 1992-93 and the National Minorities Development and Finance Corporation (NMDFC) since 1997-98. Further, the Corporation started implementing NSKFDC schemes in the State from 2015-16.

It is an acknowledged fact that NIDC, through its thrust in the transport sector, has created a genre of private transport operators and today there are private taxis and buses servicing every remote part of the State thereby alleviating the transport and communication bottlenecks, a crucial infrastructure for development.

Under various schemes, assistance amounting to over 15844.15 crore has been disbursed to 8572 entrepreneurs and the generation of employment, both direct as well as indirect, is estimated at 19420.

The bulk of the flow of assistance was directed towards the Tiny and Small Scale Sectors including Small Road Transport Operators (SRTO).

The management has, in the recent years, strengthened its recovery and follow- up departments to assess the position and performance of units assisted more efficiently. Thereof, the corporation has seen a marginal increase in the rate of loan recovery performance. However, there are still obstacles in reaching the targets set. Reasons owing to willful defaulters, prevailing social and political situations, lack of adequate and timely access to working capital and similar constraints. These factors do not only affect the corporation but also the entrepreneurs who are forced to shut down or operate below capacity and unable to service the loans.

Nevertheless, efforts have been put in to regularly improve the working capacity of its recovery departments by implementing various technological solutions to assist the overall recovery performance. It may also be mentioned that the corporation is taking legal action for recovery of dues from defaulters which has produced a positive response from the defaulters. It is thus, expected that in the years to come the rate of performance in loan recovery activities will improve.

1. Nagaland Hotels Limited

NIDCs' wholly owned subsidiary, Nagaland Hotels Limited, has established the only two hotels with 3 Star facilities, at Kohima and Dimapur. Today these two prestigious properties are serving crucial infrastructure requirements for leisure as well as business travelers.









2. SC/ST Hub - State Implementing Agency

The National SC-ST Hub has been set up to provide professional support to Scheduled Caste and Scheduled Tribe Entrepreneurs to fulfill the obligations under the Central Government Public Procurement Policy for Micro and Small Enterprises Order 2012, adopt applicable business practices and leverage the Stand Up India initiative

The Hub is being implemented by the National Small Industries Corporation (NSIC), a public sector undertaking under the administrative control of the Ministry of MSME and Nagaland Industrial Development Corporation Ltd. (NIDC) has been made the State Implementing agency for Nagaland.

3. Residential Commercial Complex

The Residential Commercial Complex was constructed during the year 1984-85. 4. Entrepreneurship and Skill Development Programmes (ESDP) Scheme under Ministry of MSME, GoI.

The primary focus of the scheme is for entrepreneurship development through skill development programmes for existing & potential entrepreneurs in order to build their capacity to take up successful business ventures. The objective of the scheme is to motivate youth representing different sectors of society including SC/ST/Women, differently abled, Ex-servicemen and BPL persons to consider self employment or entrepreneurship as one of the career options. The ultimate objective is to promote new enterprises, capacity building of existing MSMEs and inculcating entrepreneurial culture in the country.

NIDC has been nominated as the implementing agency (IA) for implementing the ESDP scheme in the State. The programme is sanctioned by the Ministry of MSME, GoI. However, the programmes under ESDP activities has been suspended as per the directives of the Ministry of MSME, GoI due to Covid-19 pandemic.

5. Construction of Water Treatment Plant at AFSEZ, Ganeshnagar, Dimapur.

It maybe apprised that in the AFSEZ certain additional infrastructure works were approved in the SLEPC, where one such work being the construction of water treatment plant which was required to be taken up immediately, since it was necessitated that such a facility be created because of its core basic requirement for the entrepreneurs within the food processing export zone for the purpose of quality water distribution to the units. Considering the nature of work for water treatment system being a specialized project, it was decided to engage the service of technical competent consultant for preparation of design & specification which was approved in the SLEPC.

In view of the above cited matter, M/s Hydratec Engineers & consultants firm, New Delhi was selected among various firms and was engaged for the preparation of the DPR for 200 m3 litre/day capacity Water treatment plant and Distribution Network at AFSEZ, Ganeshnagar, Dimapur.

On submission of the DPR, the SLEPC Committee deliberated in length on the construction of the water treatment plant where it was decided that the project to be vetted by the PHED and Geology & Mining Department. It was further decided and approved in the SLEPC that the works would be executed by the PHED Department since they have the required skills and specialization. Thus, it was decided that a MoU agreement be made between NIDC and PHED on turnkey basis. The project is now on the verge of completion and once completed will be handed over to NIDC Ltd.

6. Trade Infrastructure Export Scheme (TIES)

After delinking of the ASIDE Scheme in 2015, Trade Infrastructure for Export Scheme (TIES) was launched under the Ministry of Commerce & Industry, Govt. of India to support the States in creation of export infrastructures.

The scheme acts as an inducement to the States to channelize funds from their increased devolution towards creation of export infrastructure. The objective of the proposed scheme is to enhance export competitiveness by bridging gaps in export infrastructure, creating focused export infrastructure, first mile and last mile connectivity for export-oriented projects and addressing quality and certification measures.

The scheme would provide assistance for setting up and up-gradation of infrastructure projects with overwhelming export linkages like the Border Haat's, Land customs stations, quality testing and certification labs, cold chains, trade promotion centers, dry ports, export warehousing and packaging, SEZs and ports/airports cargo terminuses.

NIDC has been nominated as the State Nodal Agency for implementation of the scheme. The project proposals received from implementing agencies for developing critical export infrastructure

in the State is put to the State Level Export Promotion Committee (SLEPC), chaired by the Chief Secretary to Government of Nagaland for its approval as per the guidelines of the TIES scheme to be forwarded for consideration to the Ministry.

CONCLUSION

NIDC as a developmental agency has to depend on external funding for all its activities. The spread available from its term lending activities and other income generation like rent, commissions, etc., are only sufficient to meet administrative overheads. NIDC as a State Government undertaking is thus dependent on the State Government and other All India Financial institutions for funding its proposed programs.

While the overall economic changes in the country has attributed to the changed perceptions with regard to developmental funding, organizations like NIDC operating in economically underdeveloped states like Nagaland does suffer serious setbacks in its operations specially in the absence of fall - back supports.

However, NIDC has in the recent years been working on its new business ventures in tandem with the changing economic scenario for creating and infusing economic growth in the State. It may be stated that, NIDC as a developmental agency of the State Industries & Commerce department requires the support of the State Government by way of Equity Contributions, Grant for developmental activities, etc., for supporting and implementing new project ventures as well as for executing policies & programs of the Government in the industrial development of the State. This would further enable NIDC Ltd to establish itself as a catalyst for economic growth and development of the State.

11. NAGALAND HOTELS LTD. (NHL) (A SUBSIDIARY OF NIDC):

The Nagaland Hotels Limited was set up in the year 1982 as Government of Nagaland Undertaking with its 1^{st} Board of Directors Meeting held on 29^{th} March 1983 .Hotel Japfu, Kohima was set up on 14^{th} November 1988 and Hotel Saramati, Dimapur was set up on 9^{th} March 1987 respectively.

The State Government appoints the Chairman of the Board of Directors.

Presently the Managing Director is on deputation from Nagaland Industrial Development Corporation (NIDC) who is responsible for the affairs of the Company. An Officer on Special Duty (OSD) is also deputed from the Department of Industries & Commerce . The Nagaland Hotels Limited Head Office has 2 (two) General Managers assisted by subordinates Officers and Staff to oversee the day to day management of the Company.

The Nagaland Hotels Limited has 2(two) Subsidiary units in operation i.e Hotel Japfu, Kohima and Hotel Saramati, Dimapur. The two Hotel Units are managed by a Deputy General Manager and subordinates staff respectively.

12. NAGALAND HANDLOOM AND HANDICRAFTS DEVELOPMENT CORPORATION LTD., DIMAPUR:

BACKGROUND OF NHHDC LTD.: The Nagaland Handloom & Handicrafts Development Corporation Ltd. was set up in the year 1979 as Government of Nagaland Undertaking with the main objective of promoting and developing the vibrant traditional Handloom & Handicrafts products indigenous and unique to the state of Nagaland. The Corporation has its Head office at Half Nagarjan, Dimapur, Nagaland and has 8 (eight) Sales Emporium within and outside the State. The Corporation is also has a production center at its Head Office Complex where it produces both Handloom & Handicrafts products to be sold through its emporium. The Corporation also distributes raw materials to registered groups of Artisans/Weavers to enhance production on a fixed rate basis as well as procure finished goods from the registered members for sales through its own outlets i.e., Emporiums.

Further, organizing various Exhibitions, Fairs and Crafts Bazars within and outside the state are regularly carried out to provide a platform to our artisans/weavers for promotion of their products and also to educate them about the intricacies of marketing world.

<u>ADMINISTRATIVE SET- UP</u>: The Corporation functions as a Company with a Board of Directors chaired by the Chairman nominated by the Government of Nagaland. The executive set-up is managerial and is headed by the Managing Directors. At present there are 7 units i.e., Finance, Marketing, Development, Administration, Store, Recovery and Project which looks after the entire gamut of the Corporation's activities.

Activities under the Project Cell of the NHHDC during 2021-2022

1. State Handloom Expo:

During the current financial year, the Office of the Development Commissioner (Handlooms), Ministry of Textiles, Govt.of India, New Delhi has sanctioned 5 (five) Nos.State Handloom Expo 3 nos to be organized at Urban Haat Dimapur and 1 No each at Mokokchung town and Zunheboto town,Nagaland. 1 No State Handloom expo has already been conducted at Urban Haat Dimapur from 7th to 20th December 2021. Another State Handloom Expo at Urban Haat,Dimapur is under way from 10th January 2022 and the rest will be completed within the current financial year.

2. Gandhi shilp Bazar/Craft Bazar

During the current financial year,2021-2022, the Office of the Development Commissioner (Handicrafts), Ministry of Textiles, Govt.of India, New Delhi has sanctioned 1 No Gandhi shilp Bazar and 1 No Craft Bazar to be organized at Kohima town,Nagaland.The project is under process for implementation within the current financial year 2022.

3. Integrated Design & Technical Development Project

During the current financial year,2021-2022, the Office of the Development Commissioner (Handicrafts), Ministry of Textiles, Govt.of India, New Delhi has sanctioned 1 No Integrated Design & Technical Development Project for 3 month period. The project is under process for implementation within the current financial year 2022.

4. Handicrafts technical training programme

During the current financial year,2021-2022, the Office of the Development Commissioner for Handicrafts, Ministry of Textiles, Govt.of India, New Delhi has sanctioned 4 Nos of 2 months Handicrafts training programmes at Dimapur district. The project is under process for implementation within the current financial year 2022.

5. Workshop-Cum-Seminar

During the current financial year,2021-2022, the Office of the Development Commissioner for Handicrafts, Ministry of Textiles, Govt.of India, New Delhi has sanctioned 3 Nos of 1 day Wokshop-Cum-Seminars at Urban Haat, Dimapur. The project is under process for implementation within the current financial year 2022.

6. <u>Improve Toolkits distribution programme:</u>

During the current financial year,2021-2022, the Office of the Development Commissioner for Handicrafts, Ministry of Textiles, Govt.of India, New Delhi has sanctioned 4 Nos Toolkits distribution programme at Dimapur, Phek, Kipheri and Noklak District. The project is under process for implementation within the current financial year 2022.

7. Handicrafts Exhibition

During the current financial year,2021-2022, The Office of the Development Commissioner for Handicrafts, Ministry of Textiles, Govt.of India, New Delhi has sanctioned 3 Nos Handicrafts exhibition at Urban Haat, Dimapur. The project is under process for implementation within the current financial year 2022.

PRODUCTION ACTIVITIES: Production of Handloom & Handicrafts activities being of its prime objectives, the Corporation has invested an amount of Rs.6.18 lakhs only for procurement of raw materials for production at its Weaving Production Center, Dyeing Center and Craft Development Center and the total value of Production from the above centers is amounting to Rs. 17.28 lakhs. There are about 6.39 lakhs value of raw materials unused in the store.

MARKETING AND PROMOTIONAL ACTIVITIES: Finished products of the Corporation as well as those production units within the States are marketed through the sales outlet of the Corporation within and outside the State. The Corporation has invested an amount of Rs.17.36 lakhs for procurement of Handloom & Handicrafts finished products from the registered production units and has achieved a total sales amounting to Rs. 24.88 lakhs during the financial year 2021-2022 (till January 2022). The decrease in procurement and sales of emporium is due to complete lockdown for Covid-19 pandemic.

13. EASE OF DOING BUSINESS (EODB):

Since the launch of this exercise (EoDB Index) by the Central Government in line with the initiative of the World Bank, yearly Business Reform Action Plan (BRAP) is formulated by the Department for Promotion of Industry & Internal Trade (DPIIT) comprising action points to be implemented by the States/UTs.

Out of 301 action points, the state of Nagaland was able to upload evidences of 88 reform action points during 2020-21 making the overall percentage of submitted evidence at 29%. The remaining 71% could not be implemented due to the inability of many line departments to go online with their services, absence of Public Service Delivery Guarantee Act (or equivalent) and of Single Window System.

It may be mentioned that an e-portal on Ease of Doing Business (http://ebiz.nagaland.gov.in) is already developed by the State IT Department where procedures and checklists for obtaining clearances/NOCs/approvals etc for setting up of industries/units have been uploaded in the portal.

One of the key components required for successful implementation of EoDB is Single Window System (SWS) and to achieve this, the Department of Industries and Commerce in collaboration with Invest India from DPIIT, Ministry of Commerce and Industry has conducted a workshop on 17.11.2021 in the Conference Hall of the Directorate of Industries and Commerce to initiate the development of the State's Single Window System. Currently, the portal development/Know Your Approval (KYA) Module is in progress starting with key departments like Health & Family Welfare, PHED, NPCB and Tourism.

Ramietech Solutions has submitted a concept note on EoDB; as follow up of this, the department and EoDB Team had a meeting with Ramietech Solutions on 25.01.2022. The latter presented a power point on EoDB and highlighted on the services that they can provide in the implementation of EoDB in the state.

14. NORTH EAST INDUSTRIAL DEVELOPMENT SCHEME (NEIDS), 2017:

The Government of India has approved a package of fiscal incentives and other reimbursements for the North East Region namely the North East Industrial Development Scheme, 2017. It was notified by the government on 12^{th} April 2018 and the scheme is applicable for 5 years effective from 01.04.2017 to 31.03.2022.

The scheme aimed to boost industrialisation and generate employment through a combination of incentives; all new industrial units both in manufacturing and service sector are eligible. Prior to commencement of operation, the applicant has to get registered at the NEIDS portal under the Ministry of Commerce and Industry and all claimants of incentives available under NEIDS 2017 are processed online in a time bound manner.

Incentives available under NEIDS:-

- 1) Central Capital Investment Incentive for Access to Credit (CCIIAC)
- 2) Central Interest Incentive (CII)
- 3) Central Comprehensive Insurance Incentive (CCII)
- 4) Goods and Service Tax (GST) Reimbursement
- 5) Income Tax (IT) Reimbursement
- 6) Transport Incentive (TI)
- 7) Employment Incentive (EI)

In order to take the NEIDS scheme forward, awareness programmes on the scheme has been organised by the Department of Industries & Commerce in all the district headquarters so as to disseminate the guidelines and the information to the entrepreneurs.

The Scheme requires that all eligible industrial units would have to register under the Scheme with DPIIT, Ministry of Commerce & Industry, Govt. of India, through the portal to be eligible for any benefit under NEIDS, 2017. In this regard, an online application process has been developed and the Portal can also be accessed through the website: www.dipp.gov.in.

A State Nodal Officer from the Directorate has been nominated and each DIC has nominated Nodal Officer (The General Manager) in order to get registered and log in to the portal and view the dashboard including the applications submitted.

A total number of 3 (Three) units has been forwarded to Department for Promotion of Industry & Internal Trade (DPIIT) to obtain registration. So far, the approval for registration has been granted to two units (i.e. Liniza Garment Manufacturing Unit and Atoqa Tea producer Company Limited) and one unit is under evaluation.

15. REGULATORY COMPLIANCE BURDEN (RCB):

The Government of Nagaland in line with the Government of India directive has initiated the process to reduce the Regulatory Compliance Burden (or burdensome compliances) for businesses and citizen-centric services. The objective of this exercise is to repeal, reduce or rationalise these compliances while minimising the physical touch points. Five specific sectors were identified as the key sectors namely tea, bamboo, fisheries, dairy and tourism which have the potential for growth and investment in the State. Sub-Nodal Officers of 53 Departments have been nominated and their details were uploaded in the portal managed at the State Level by the Industries & Commerce Department. The Commissioner & Secretary, Industries & Commerce Department is the Nodal Officer for the State. A State level task force under the chairmanship of the Chief Secretary to monitor the exercise of minimising Regulatory Compliance Burden has been constituted on 7th July 2021 with 10(ten) members of the line departments.

The Ease of Doing Business (EoDB) team visited the line departments and based on the inputs received from the departments, the data of identified compliances has been prepared and stated below:-

16. INDIA INDUSTRIAL LAND BANK (IILB):

Department for Promotion of Industry & Internal Trade (DPIIT), Ministry of Commerce and Industry has developed IILB portal, which is a GIS-enabled database of industrial areas/clusters across the country to adopt a committed approach towards resource optimization, industrial up gradation and sustainability. The portal serves as a one-stop solution to the free and easy accessibility of all industrial information including industrial parks, availability of raw materials, agriculture, horticulture, minerals, natural resources, distance from key logistic nodes, layers of terrain and urban infrastructure. It aims to provide information on available land for prospective investors looking at setting up units in the country. It also provides links to State GIS Portals and State Land Banks. Integration of Industrial Parks into IILB portal for the state of Nagaland is on progress which can be access through the link https://iis.ncog.gov.in/parks/login1.

IPRS 2.0 Exercise: Industrial Park Rating System (IPRS) is an exercise to rank the Industrial Parks of the States/UTs, it revolves around 4 (four) key pillars

- 1)External infrastructure
- 2)Internal infrastructure
- 3) Business support services
- 4) Environment and safety

The state has nominated 3(three) Industrial Parks for IPRS 2.0 namely

- 1) New Industrial Estate, Dimapur
- 2)Old Industrial Estate, Dimapur
- 3) Integrated Infrastructure Development Centre (IIDC), Kiruphema

IPRS 2.0 report was released on 5^{th} October 2021 with the Industrial Parks in India ranked in 3(three) categories

1) Leaders: 41 Industrial Parks

2) Aspirers: 185 Industrial Parks

3) Challengers: 90 Industrial Parks

137th: New Industrial Estate, Dimapur

17. STARTUP INDIA:

As Part of the implementation of Startup Nagaland Policy 2019 and in order to promote startup culture and innovation in youth of Nagaland, the following activities have been initiated.

- The Department has signed MOUs with 4(four) Incubators: National Institute of Electronics & Information Technology (NIELIT), Nagaland Tool room and training centre (NTTC) YOUTHNET, and Educentre. Financial Support of Rs.25 lakhs each is allocated to each Incubator in installments for assisting Startups by providing plug & play facilities, R & D activities, etc.
- The Department has also signed an MoU with YouthNet, one of the incubators, to set up Entrepreneurship Development Cells (EDC) in schools and colleges (in line with the state startup policy 2019) with an aim to nurture and promote entrepreneurship at the learning stage.
- The Department has also extended financial assistance to YouthNet to conduct a Women Entrepreneurship fellowship during the year 2020.
- Lockdown Challenge 2020 for aspiring & innovative youth was conducted. The Lockdown challenge 2020 was to help ignite young minds at home to come up with innovative ideas/solutions, products to help tackle the COVID situation in the state. A total of 30 (thirty) people had won cash prizes for their solutions and products.
- In the year 2021 the Department assisted four Incubators to hold innovative challenges for startups wherein the winners of the competition were incubated and assisted financially to further develop their products/services.

19. ECONOMIC PLANT:

Economic Plant is one of the functioning and producing Branches in the Department. Citronella oil is an essential Oil obtained from the leaves and stem of different species of cymbopogon (lemongrass). The oil is use extensively as a source of Mosquito and insects repellent and also used in cosmetic perfumes.

At present, there are 10(Ten) Farms in the state namely Training-Cum- Production Centre, Sirhima, Mongsenyimti EP Farm, Kubulong EP Farm, Liroyimti EP Farm and Tuli EP Farm under District Industries Centre, Mokokchung, Chingmei EP Farm under District Industries Centre,

Tuengsang, Yongnyah EP Farm under District Industries Centre, Longleng District, Leangyu EP Farm under Mon District, Chukitong EP Farm under District Industries Centre, Wokha, Losami EP Farm under Sub-District Industries Centre, Phek respectively. Out of 10 (ten) EP Farms, only (6) six units are functioning with low output of oil because of wear and tear of distillation units and the rest of the Farms need new Distillation units. All together 112 liters was produced during 2020-2021 and its market value is estimated at Rs.1,68,000/- (one lakh sixty eight thousand) only. During March 2020-2021 we could not received Citronella Oil as expected due to Covid-19 Pandemic Lockdown.

The Department have also submitted the concept note for revival of all citronella Farms and units established under the Department of Industries & Commerce in tune of Rs. 464.75/- (Rupees four crores sixty four lakhs seventy five thousand only) which is in priority list under NEC for the year 2021-22.
