ANNUAL ADMINISTRATIVE REPORT OF 2023-2024.

Introduction:

The Department of Industries & Commerce is endeavoring to promote Industrialization in the State through various Industrial and commercial activities including Hospitality and Business Service sector in the State.

The task of the Department is, however, a difficult one. The remoteness of the State along with poor industrial infrastructure like road linkages/ Electricity were the major problems. The second is the special land laws that restrict the transfer of land to non-locals.

The Government of Nagaland and the Industries & Commerce Department is of the view that the State needs infrastructure led growth and therefore stressing more in the development of infrastructure structure in the State. The Department has so far created the following infrastructures in order to facilitate the Industrial growth in the State.

- a) Industrial Growth Centre (IGC) at Ganeshnagar, Dimapur.
- b) Export Promotion Industrial Park which is now being up graded to Product Specific Special Economic Zone (SEZ).
- c) Nagaland Tool Room & Training Centre (NTTC) Dimapur aimed with Human Resource Deployment in the Industrial Sector.
- d) Industrial Infrastructure Development Centre (IIDC) at Kiruphema.
- e) Four Industrial Estates (ID) Mokokchung, Mon, Peren & Dimapur during current plan period.

In order to carry out all such tasks, the following are the structures of the Department:

- A. Administrative set up: The Commissioner & Secretary to the Government of Nagaland Shri Kekhrievor Kevichusa, IPoS heads the Administrative Department.
- (a) Directorate: A Director heads the Directorate, who is assisted by 29 (twenty nine) Officers, 5 (five) Inspectors and 123 Ministerial & Grade-IV Staff. A Construction Wing (Housing Div-VI) attached to the Directorate is headed by an Executive Engineer who is assisted by three SDOs, one Divisional Accounts Officer, three Junior Engineers and seven Sectional Officers to look after all civil works under the Department including PSUs under the control of the Department.
- (b) District Industries Centre (DIC): There are 11 (eleven) full-fledged DICs headed by the General Manager and assisted by Functional Managers & Inspectors and 14 (fourteen) Sub-DICs headed by a Functional Manager and assisted by Inspectors.

The Department of Industries & Commerce imparts various skill and unskilled training Programme every year and is looked after by Training & Exhibition Branch. Various Training Programme initiated are as given below:

- 1. Rural Industrial Programme: Programme like Weaving, Handicraft and Stenography are provided under the programme and duration of this programme is for 12 months. The Tranining for this programme are Textile & Design Training Centre Dimapur and District Industries Centre: Mokokchung, Tuensang, Mon, Longleng, Zunheboto, Kohima and Sub-District Industries Centre Aghunato. A monthly stipend of Rs 500 per student is also provided.
- 2. Rural Artisans Programme: The duration under this programme is for 9 Months. The Programme like Electronic, Automobile, Sheet Metal and Welding Training are provided at Textile & Design Training Centre, Dimapur. Other programmes like Cutting & Tailoring Training is provided at District Industries Centre: Chozuba, Kiphire and Peren. A monthly stipend of Rs 500 per student is also provided.
- 3. Short Term Training Sponsored by the Department: Prorammes provided under this are for 6/4 months durations. Beauty & Wellness, Designed and Tailoring are provided at Nagaland Women Vocational Training Institute, Dimapur. And programmes like Embroidery & Tailoring and Traditional Jewelry Designing are provided at Nagaland Women Vocational Training Institute, Kohima. A monthly stipend of Rs 500 per student is also provided.

- 4. Handloom Technology Training: The Department also sponsored and sent students at Indian Institute of Handloom & Textiles Technology (IIHT) Guwahati for Handloom Technology Programme for 5 Years. A monthly stipend of Rs 500 and Yearly Book Grant per student is also provided.
- 5. Republic Day: Every Year, the Department also participates during the Indian Republic Day Celebration on 26th January at Secretariat Plaza, Kohima and exhibits various indigenous products like Naga Handloom & Handicraft and Citronella products of the Department.
- 6. Hornbill Festival: During the 10 days celebration of the Hornbill Festival at Naga Heritage Village Kisama from 1st to 10th December every year, the department organized exhibition cum sale of the various local products at the department's Bamboo Pavilion by allotting 108 stalls to various local entrepreneurs to exhibit cum sale of their products.
- 7. India International Trade Fair (IITF): The Department also participates during the India International Trade Fair which is organized by India Trade Promotion Organization every year from 14th Nov to 27th November at Pragati Maidan New Delhi. During the Trade Fair 2023, the Department has constructed a State Pavilion with 25 stalls displaying various Naga Indigenous products like Handloom & Handicrafts and Food products. During the 42nd Edition of the India International Trade Fair 2023, Nagaland Pavilion was adjudged an Award of Special Appreciation Medal for Excellence in Display for the Thematic Presentation in the State Category.



3. FOOD PROCESSING INDUSTRY (FPI):

1. Supporting Individuals in establishing/upgradation of micro food processing units under PMFME Scheme:

A total of 1560 applications received from interested individuals for availing benefits under Pradhan Mantri Formalisation of Micro Food Processing Enterprise (PMFME) Scheme. Currently, 133 individual beneficiaries have availed credit linked subsidy, 118 applications are pending with the bank and the rest under review for approval.

Seed Capital Money to SHGs:

Collaborating with the NSRLM and NULM departments, a total of 3797 Self Help Groups (SHGs) were identified to receive seed capital under the PMFME Scheme. Among them, 3454 SHGs were recommended by NSRLM, while 343 SHGs were recommended by NULM.

An official disbursement of Rs.6,90,30,946/- (Rupees Six Crore Ninety Lakh Thirty Thousand Nine-Hundred and Forty-Six Only) took place through One-Click disbursement by Smti. Hekani Jakhalu, Hon'ble Advisor, Industries & Commerce, at the Director's conference hall, Directorate of Industries & Commerce on 7th December 2023.

3. Capacity Building:

Nagaland emerged as the top-performing state in Capacity Building during the FY 2023-24. As on January, 2024 a total of 1568 individuals have been trained under PMFME Scheme - 203 DLC recommended beneficiaries and 1365 seed capital beneficiaries. Applicants passing the District Level Committee (DLC) Approval stage are undergo a three-day training on EDP and Product Domain, while SHG members who received seed capital money receive one-day training.

4. Mini Tri-Food:

Working in coordination with TRIFED's implementing agencies, twelve Mini Tri Food projects are supported under the Scheme, comprising 4 units under DUDA and 8 units under MARCOFED. Additionally, a proposal for establishing 2 units under NBHM has been submitted and is awaiting administrative approval.

5. Common Incubation Centre (CIC):

An Incubation Centre has been established at SASRD, Medziphema, featuring diverse processing lines like primary processing, dehydration, canning, beverage making, pickle and food testing lab. This centre is set to serve the purposes of incubation, training, and commercial production. Currently, installation of plant and machinery in progress.

6. Branding & Marketing:

The State Nodal Agency for PMFME Scheme and M/s Cold Mountain have jointly formed a Special Purpose Vehicle (SPV) under the name of Cold Mountain Food Processing Marketing Co-operative Society for providing Branding and Marketing support to individual micro food processing enterprises, Self Help Groups, Farmer Producer Organizations, Producer Cooperatives etc. so that their products could find place in supermarkets, malls, retail chains, etc. across the country as well as overseas. This initiative will go a long way in enhancing their competitiveness and helping them formalize and earn better returns for their produce. The Special Purpose Vehicle (SPV) has identified King Chilly Products, Kholar (Rajma), Pineapple, Ginger & Pickle products for the purpose.

The objective of running the SPV shall be to provide:

- a) Training relating to marketing;
- b) Developing a common brand and packaging including standardization to participate in common packaging.
- c) Marketing of ODOP products
- d) Marketing tie-up with national and regional retail chains and state-level institutions;
- e) Standardization of ODOP products
- f) Quality control to ensure product quality meets the required standards.
- g)The SPV/implementing agency will ensure that necessary infrastructure like provisioning of land and building including water and power supply are in place.

7. Promo Activities:

- a. Statewide Seminar was conducted in the month of May and June, 2023 in 36 Blocks covering all 16 Districts, with the support of DICs/SDICs, NRLM, NULM and NEIDA in pre-identifying potential food processing entrepreneurs.
- **b.** The first edition of the Nagaland Food Connect was organised under PMFME Scheme at Bamboo Pavilion, Kisama during Hornbill Festival 2023 under the theme Promoting Foodpreneurs. The event aims to elevate local food processors while fostering and supporting women in the realm of food processing industry.
- **c.** The FPI team also participated in the following events, along with local entrepreneurs for exhibition and sale of locally processed food.
 - i. North East Food Event 2023 held at Maniram Dewan Trade Centre, Guwahati from 29th – 31st March 2023
 - ii. G20 Summit, 2023 held at Kisama Heritage Village from 4th 6th April, 2023.
 - iii. World Food India, 2023 held at New Delhi from 3rd-5th November, 2023.

4. MICRO, SMALL AND MEDIUM ENTERPRISE (MSME):

The Micro, Small and Medium Enterprise (MSME) sector is an important pillar of Indian economy as it contributes greatly to the growth of Indian economy with the vast network of around 6.3 Enterprises creating an employment of about 6.3 Crores. The department of Industries & Commerce, Nagaland being the facilitator and promoter for the development of Industrial Enterprises of the state has been leveraging the information (Schemes and Benefits) under MSME Sector to promote entrepreneurs and develop enterprises in the state. While keeping in mind the importance of the roles of MSME sectors, the department in collaboration with the MSME-DI Dimapur has been proactive in organizing different programmes and disseminating every information received from the Ministry.

REGISTRATION OF INDUSTRIAL UNITS:

The Government policies on industrial development as well as on credit facilities were mainly focused on manufacturing units in the small-scale sector. And in the past decades, the lowering of trade barriers across the globe has increased the minimum viable scale of enterprises. The size of the units and the technology employed for various firms to be globally competitive at present is also of a high order. Hence, in keeping with the global practice the central Government through an Act of the Parliament introduced a new system bringing about a paradigm shift from tiny/cottage, small scale and Medium Industry to Micro Small and Medium Enterprises (MSME).

The MSMED Act 2006 marked a shift from SSI (Small Scale Industry) approached to SME (Small and Medium Enterprises) approach. Enterprises are classified as Manufacturing and Service Enterprises based on nature of activity of the Enterprises. Manufacturing and Service Enterprises are further classified into Micro, Small and Medium Enterprises on the basis of investment in plant and Machinery/ Equipment. As per MSMED Act 2006, the investment limits of all categories of enterprises are shown below:

Udyam Registration

Classification of MSMEs and Procedure for Registration w.e.f 1st July, 2020.

A detail notification on the changes regarding revision of definition of MSME and process of registration has been brought out vide Notification No. S.O.2119 (E) dated 26.06.2020. Apart from the old criteria of categorization of criterion of turnover the differences between manufacturing and services sector has been removed and now both are on the same level of treatment. This new classification and the frame work are expected to bring a new eco-system development of MSME sector in an integrated manner.

With the Government Notification OM.No. 5/2(1)/2020-P&G/Policy Dated 17.07.2020 Udyog Aadhaar Memorandum (UAM) has replaced with Udyam Registration.

The Government has developed a system of facilitation for registration of Udyam Process w.e.f. 1.7.2020 as given below:

- An Enterprise for the purpose of this process will be known as Udyam and its registration process will be known as "Udyam Registration".
- The registration portal is www.udyamregistration.gov.in
- MSME registration process is fully online, paperless without any need to upload any
 document and based on self-declaration. Only Aadhaar number will be enough for the
 registration.
- Permanent registration will be given after registration
- After completion of the process of registration, a certificate will be issued online with QR code.
- PAN & GSTIN would be mandatory from 01.04.2021
- PAN & GST linked details about investment and turnover of enterprise will be taken automatically from Government Data base.
- No enterprise shall file more than one Udyam registration. However, any number of activities including manufacturing or service or both may be specified or added in one registration.
- Erstwhile EM-II or UAM registration or any other registration issued by any authority under the ministry of MSME, will have to migrate to Udyam registration portal or file Udyam registration afresh.
- Single window system at Champions control room at MSME DIs and DICs will act as facilitator in the process.
- There will be no need of renewal of registration. Registration process is totally free.

At present, total MSME Udyam Registration in Nagaland stands at 20,520. Dimapur district has the highest registration followed by Kohima district. With the ongoing sensitization programme in all the districts for the existing UAM and EM-II registered units to migrate to the new system of Udyam Registration, the registration is expected to grow even more.

Addition of activities (NIC Code) under MSMED Act 2006 for Udyam Registration-Retail & Wholesale Trade.

As per the Ministry's O.M No.UAM/MC/01/2017-SME dated 27th June 2017 certain activities were not covered under MSME Act 2006 and were not permitted for registration on UAM portal. However, the eligible additional activities under NIC code 45,46, & 47 have been considered as MSME and granted permission to be registered on Udyam registration portal. However, the benefits are to be restricted to priority sector lending only. And, consequent upon changes, OM. NO. 5/2/(1)/2020/E-P&G/Policy Dated 10/12/2020 stands omitted.

5. STATE INDUSTRIAL POLICY-2000 (REVISED 2004):

Introduction:

The State Industrial Policy-2000 was revised in 2004 in order to provide better facilities to entrepreneurs/industrialists for promotion enterprises both in manufacturing and service sectors. Some of the main objectives of the Policy are (i) To create conditions for rapid industrial development and conducive investment climate; (ii) Create gainful employment opportunities for local population; (iii) Develop human resources and bring about improvement in the quality of life by promoting industrial ventures in sectors in which the State has a comparative advantages; (iv) Develop entrepreneurial and other technical skills of the available human resources; (v) Develop industrial infrastructure in selected areas; (vi) Promote Export Oriented Units with a view to exploit the emerging market opportunities in the neighbouring countries; (vii) Provide investor friendly environment by removing procedural bottleneck and legal hurdles; etc. The following are the Incentive Schemes:

- i) Power Subsidy: Subsidy on power tariff @ 30% & 25% given for connected loads upto 1 MW & above 1 MW respectively for a period of 5 yrs. from the date of commercial production subject to a maximum ceiling limit of Rs.2 lakh annually.
- (ii) Drawal of Power Line: Cost of drawal of 33/11 KV line to eligible units located outside the notified areas shall be reimbursed for one time only subject to a ceiling of Rs.2 lakh (now as per NEIIPP-2007, anywhere in the State)
- (iii) Subsidy for Feasibility Study cost:Subsidy @ 50% of the cost of DPR subject to a ceiling of Rs.1 lakh is eligible for new units with investment in plant & machinery above Rs.25 lakh
- (iv) Manpower Subsidy: 25% of the actual wage bill for local tribal employees employed by eligible units for 3 yrs. from the date of entertainment subject to a maximum ceiling of Rs.1 lakh annually for those units where the investment in plant & machinery is from Rs.5 lakh to Rs.25 lakh, Rs.2.50 lakh annually for units where the investment in plant & machinery is from Rs.25 lakh to Rs.100 lakh and Rs.5 lakh annually for units where the investment in plant & machinery is above Rs.100 lakh.
- (v) Subsidy for Quality Control measures: Cost of laboratory equipment for the purpose of quality control and ISI/BIS/ISO 9000 certification is reimbursed subject to a maximum ceiling of Rs.50,000/- in case of small scale and Rs.1 lakh in case of medium & large units.
- (vi) Stamp Duty Exemption: 50% Stamp duty & Registration fee for securing loans from Financial Institutions including Mortgage of fixed assets are exempted from the Stamp Duty Act for a period of 5 yrs.
- (vii)Stipendiary Support for EDP:Rs.500/- p.m. per trainee is provided for 100 youths annually for training period not less than 3 months duration.
- It may be mentioned here that the Department has already decided to revise the SIP in accordance with the policies and programmes of the State Government and other line Departments of the State as well as the Central Ministries.

6. PRIME MINISTER'S EMPLOYMENT GENERATION PROGRAMME (PMEGP):

Prime Minister Employment Generation Programme (PMEGP) is a Central Sector Scheme administered by the Ministry of Micro, Small and Medium Enterprises (MSME). The Scheme is implemented by Khadi and Village Industries Commission (KVIC) functioning as the nodal Agency at the National Level. At the state level, the Scheme is implemented through State KVIC Directorates, State Khadi& Village Industries Board (KVIBs) District Industries Centre (DICs) and Coir Board.

The Scheme aims to provide continuous and sustainable employment to a large segment of traditional and prospective artisans, rural and urban unemployed youth in the country through setting up of micro enterprises, to facilitate participation of financial institutions for higher credit flow to micro sector.

Each year under Backward Forward Linkages Programme of PMEGP, the Department carry out awareness Camp in different districts. For the year 2023-24, 8(Eight) Awareness camp was held in eight districts/Blocks- Bhandari, Pughoboto, Tuensang, Dimapur, Kiphire, Mon, Mokokchung and Kohima to create awareness about the Scheme and 16(Sixteen) District Level Monitoring Committee Meeting (DLMC) headed by the Deputy Commissioner of the Districts was held to monitor the implementation of the Scheme.





7. ENTREPRENEUR AWARD:

To celebrate innovation and success as well as to encourage and promote the culture of entrepreneurship in the State, the first ever Entrepreneur Award was initiated by the Department. The Award represents Entrepreneurial enthusiasm to excel. This Award is given to the best industry talent who have not only excelled in their field but also shown doggedness, commitment and undying passion for building a business.






Fig. Banana Fibre Processing Machinery at Rüsoma Village






5. AGREEMENTS SIGNED:

With a view to play a pivotal role as a major stakeholder for cluster development projects, NTTC focuses on capacity building development programmes on design and development of various utilities and other craft products as well as to impart training to new and existing artisans through tailor made and customized skill development. NTTC has been empanelled as Technical Agency with MSME-Tool Room, Guwahati and Indian Institute of Entrepreneurship (IIE), Guwahati towards implementation of the SFURTI Scheme to promote and rejuvenate traditional industries, boost livelihood generation and socio-economic development in the region. NTTC had organized virtual webinar on the scheme guidelines and application process where various NGOs, SHGs and entrepreneurs from across the NE States had participated.

Advertisement for inviting Implementing Agencies has been published in local dailies where it received and is being receiving proposals from NGOs, SHGs. The detail project reporton Cane & Bamboo Cluster, Kiphire and Stone Craft Cluster, Sechü-Zubza, Kohimafor cluster development projectshave been prepared and submitted to the Nodal Agency i.e. Tool Room & Training Centre (TRTC), Guwahati.

Further, the baseline survey including the preparation of diagnostic study research and project reports on Bee-Hive Keeping Clusterand King Chilly Processing Cluster are in progress.

7. AGRO-BASED RURAL TECHNOLOGY & INCUBATION CENTRE:

NTTC has set up Agro-Based Rural Technology & Incubation Centre under the Ministry of Micro, Small and Medium Enterprises (MSME), Govt. of India. Good number of appropriate rural technology, improvised agro based machineriesincluding rural technologies such as Foddorizer, Smokefree Meat Dryer, Fruits & Vegetable Dryer (Solar), Banana Fibre Extractor, Corn Sheller, Chaff Cutter, Maize Crusher, Bamboo Shoot Slicer, Fodder Cutter, Arecaleaf Cup/Plate Making Machine, Wood & Bamboo Chipping Machine, Hollow Block Making Machine, Portable Stone Cutting Machine, Paper Pulp Machine etchave been developed to harness the rich natural resources like bamboo, banana-pineapple fibre, meat and vegetable processing and preservations for enterprise creation. With the mission of Startup India, NTTC is providing an enabling ecosystem to support and nurture startup entrepreneurship to enthusiast entrepreneurs as well as engaging with stakeholders for strengthening the start-ups with mentoring and appropriate facility.

10. HOSTEL CONSTRUCTION UNDER AICTE SCHEME 'CAMPUS ACCOMMODATION & FACILITIES ENHANCING SOCIAL EXPERIENCE (CAFES)':

9. NAGALAND KHADI & VILLAGE INDUSTRIES BOARD, KOHIMA

The Nagaland Khadi & Village Industries Board is a statutory body constituted by the Government of Nagaland under the Act – (No. 5 of 1978) of Nagaland Legislative Assembly and it started functioning in January 1979. The main function of the Board is to implement the programmes in accordance with the Khadi & Village Industries Commission (KVIC) pattern of assistance from time to time. Thus, the NKVIB is not a profit making organization of its own but to implement the programmes and scheme of KVIC by providing assistance in the form of marginal grant to the beneficiaries/units financed by the banking agencies under PMEGP scheme to promote Khadi & V.I. activities in the State.

As per the provision of the Act, under Chapter V Clause – 25(i) "... the establishment expenditure of the State Board will be the sole responsibility of the State Government. Similarly it may grant subvention compensation irrecoverable debts."

2) EDP TRAINING TO PMEGP BENEFICIARIES:-

The beneficiaries financed under PMEGP Scheme are compulsory to undergo 2 weeks EDP Training in the designated Institutions of KVIC. The Khadi & Village Industries Commission had placed entire Training budget allocation for the year 2023-24 to State KVIC Office, Dimapur to conduct EDP Training in the State of Nagaland for those unit financed by financing agency (Bank) under Margin Money Scheme (PMEGP). 5) Khadi Plaza (Haat):

The KVIC has agreed in principle for establishment of a Khadi Plaza (Haat) at Dimapur, where the expenditure will be met by the KVIC and the State Government on the basis of 90:10 ratios in a phased manner. The Nagaland Hotels and Tourism Development Corporation Limited with its 2 (two) Subsidiary units in operation i.e Hotel Japfu, Kohima and Hotel Saramati, Dimapur with well-managed ambience of three star category facilities have been providing services to both international and domestic clients. Both the hotels are registered members of the Federation of Hotels and Restaurant Association of India (FHRAI) and the Hotels and Restaurant Association of Eastern India (HRAEI).

The State Government appoints the Chairman of the Board of Directors.

11. NAGALAND HANDLOOM & HANDICRAFTS DEVELOPMENT CORPORATION LTD., DIMAPUR:

BACKGROUND OF NHHDC LTD.: The Nagaland Handloom & Handicrafts Development Corporation Ltd. was set up in the year 1979 as Government of Nagaland Undertaking with the main objective of promoting and developing the vibrant traditional Handloom & Handicrafts products indigenous and unique to the state of Nagaland. The Corporation has its Head office at Half Nagarjan, Dimapur, Nagaland and has 8 (eight) Sales Emporium within and outside the State. The Corporation also has a production center at its Head Office Complex where it produces both Handloom & Handicrafts products to be sold through its emporium. The Corporation also distributes raw materials to registered groups of Artisans/Weavers to enhance production on a fixed rate basis as well as procure finished goods from the registered members for sales through its own outlets i.e., Emporiums. Further, organizing various Exhibitions, Fairs and Crafts Bazars within and outside the state are regularly carried out to provide a platform to our artisans/weavers for promotion of their products and also to educate them about the intricacies of marketing world.

ADMINISTRATIVE SET- UP: The Corporation functions as a Company with a Board of Directors chaired by the Chairman nominated by the Government of Nagaland. The executive set-up is managerial and is headed by the Managing Directors. At present there are 7 units i. e., Finance, Marketing, Development, Administration, Store, Recovery and Project which looks after the entire gamut of the Corporation's activities.

Financial Statement of the Head Office and the two Hotel Units for the year March 2023 to January 2024 is given below:

Activities of the NHHDC during 2023 -2024

1. State Handloom Expo:

During the current financial year, the Office of the Development Commissioner (Handlooms), Ministry of Textiles, Govt.of India, New Delhi has sanctioned 3 (three) Nos. State Handloom Expo. Details as under:-

- a. 28th April to 11th April 2023 at Urban Haat, Dimapur.
- b. 09th October to 22nd October 2023 at Urban Haat, Dimapur.
- c. 05th December to 18th December 2023 at Town hall, Phek.

PRODUCTION ACTIVITIES: Production of Handloom & Handicrafts activities being of its prime objectives, The Corporation has invested an amount of Rs.13.42 lakhs only for procurement of raw materials for production at its Weaving Production Center, Dyeing Center and Craft Development Center and the total value of Production from the above centers is amounting to Rs. 28.74 lakhs. There are about 10.16 lakhs value of raw materials unused in the store.

MARKETING AND PROMOTIONAL ACTIVITIES: Finished products of the Corporation as well as those production units within the States are marketed through the sales outlet of the Corporation within and outside the State. The Corporation has invested an amount of Rs.30.60 lakhs for procurement of Handloom & Handicrafts finished products from the registered production units and has achieved a total sales amounting to Rs. 40.16 lakhs during the financial year 2023-2024 (till January 2024).

MARKETING SOURCES & TARGET: The Nagaland Handloom & Handicrafts Development Corporation Ltd. is the only establishment in the state obligated for development and promotion of rich traditional and modern designed handloom & handicrafts of Nagaland. Survey reveals that it has the viability across the country to penetrate into national market.

These days, since online shopping is gaining momentum the Corporation has started marketing out its products online through Instagram and Facebook page with the brand name 'MERAKI'. The Corporation is also planning to sell out variety of Naga products through online marketing channels viz. Amazon & Etsy too if adequate finding is made available by the state Government.

BUDGETARY PROVISION:

The Corporation incorporated in the year 1979 came into being without any budgetary provision in terms of salaries for its employees and Administrative Expenses. The Corporation was in receipt of yearly capital investments in the form of Equity Share till year 2012-2013 since then the Corporation has received no working capital form the Government. As such expenditures are inevitable. The State Government is requested once again for its kind perusal for budgetary requirements of NHHDC Ltd.

CONCLUSION: With the abundant availability of skill and resources, the Handloom & Handicrafts sector has the potential to grow and contribute positively to the economy of the State. More importantly, the development of this sector would directly influence the income and standard of life of weavers and artisans in the rural areas that in turn would account for economic and social development in the rural areas has almost every house hold in the villages of the State can be boast of having skilled weavers and craftsmen. The Corporation recognizes this tremendous potential and is also working towards creating awareness about this sector through its various activities.

In view of the above stated facts, the Government is requested to assist the Corporation in all possible manner so as to enable NHHDC Ltd. to achieve its objectives fully.

12. COMMERCE SECTION:

1. Directorate of Industries & Commerce, Kohima is the Nodal Department for promotion of Exports in the State.Hence, as a responsible organization and facilitator conducted a One day "Export Awareness Programme" on 24th July 2023 for promoting local exporters and export business of our state in collaboration with the Directorate General of Foreign Trade (DGFT) Government of India. The event witnessed the participation of senior Officers of Horticulture/Agriculture/Land Resources/Postal office and other stakeholders who gave valuable suggestions and technical aspects of Export promotion.

Smti. Hekani Jakhalu, Advisor Industries & Commerce, Government of Nagaland in her address emphasized the importance of convergence/collaboration between Departments to ensure success in the State's Export sector. She urged the Departments to collaborate closely, particularly with Agri and allied Departments to achieve the desired outcome. Shri. Amit Sharma, Joint DGFT in his technical speech, highlighted the significance of exports focusing on institutionalizing and expanding export practices.

He also shared the role of Trade Promotion Wing, which is a recent development. He also suggested and advised that, until the time, when infrastructure, logistics and connectivity improves, at least to start Awareness program and sensitizing the people on the benefits of exports and foremost to focus and start with sensitizing the Government officials especially to strengthen the G.Ms who are the extension level officers and also requested the State Government to share and collaborate more with DGFT.

During the technical session resource person from DGFT, Customs Department, Indian Post Office, NIDC, MOVCDNER shed their lights on ranges of topics in regard to export promotion and its various activities like Export documentation and procedures, Export Schemes, Custom Export Procedures, Dak Ghar Niryat Kendra, Special Economic Zone (SEZ), Prospect of export on organic certified food products (under MOVCDNER). Altogether 70 participants including officials attended the awareness program.

(A special highlight of the event was Dak Ghar Niryat Kendra (DNK) (Export Service Centre), an initiative /new Postal service which provides great opportunity for small exporters/entrepreneurs who wish to export to foreign countries.)





2. A virtual meeting on Open Network for Digital Commerce (ONDC) was held on 16th November 2023 in the Conference Hall, Directorate of Industries & Commerce Kohima. Open Network for Digital Commerce (ONDC) is a flagship initiative of Department of Promotion of Industry and Internal trade (DPIIT), Ministry of Commerce and Industry aiming at promoting open networks for all aspects of exchange of goods and services over digital or electronic networks.

ONDC is expected to democratize, enhance the access and increase the participation of digital commerce in India.it will also enable small businesses, traders, MSMEs, Start-ups, artisans, handicraftsmen, farmers etc. retailers to sell their product and services digitally to consumers across India.

Smti. Pooja Bajaj Bagaria, Incharge for state engagement for the Eastern state in India and Resource person gave a detailed presentation on the modules of ONDC and the revolution that this platform will bring in the digital commerce.

Altogether 30 participants from different domains and Govt. officials attended the VC meeting.



Background & Ownership of the Corporation

The Corporation is a Government of Nagaland undertaking, incorporated under the Companies Act, 1956 on March 26, 1970 with the objective to Promote, Develop, Establish and Assist industries in the State.

With an Authorized Capital of Rs.25 Crore, the Paid-up Capital as on 28th Feb 2022 stands at Rs. 23.20 Crore of which equity of Rs. 4.73 Crore and Rs. 18.46 Crore are subscribed by the IDBI and the State Government respectively.

Activities of the Corporation

With the objective to promote, develop, establish & assist industries in the state, NIDC has played a significant role in taking up several major projects to contribute to the industrial development of the state. The contribution's made comply with the infrastructural & employment generation needs of the state and have been demonstrated as follows:

1. Industrial Estates

NIDC manages and maintains two Industrial Estates at Dimapur, which were taken over from the State Government in 1976. The Industrial Estates covering a total area of 40 acres has 25 ready built Standard Factory Sheds, which are rented out to industrial units at concessional rates.

2. Special Economic Zone (AFSEZ) at Ganeshnagar

The Government of India (GOI) has taken several initiatives aimed at developing Special Economic Zones in the country in order to promote exports and develop regional infrastructure. In reference to the same, Nagaland Industrial Development Corporation Limited (NIDC) identified Dimapur as the location for the Special Economic Zone and a SEZ was created with the approval from the Ministry of Commerce vide No. F.1/149x2007-SEZ dated July 9, 2009; the Project was planned across an area of 125 acres. The SEZ aims to offer a perfect blend of industrial, business and social infrastructure in the midst of lush and green eco-friendly environment incorporating the latest state of the art green technologies.

Additionally, with the intention of widening the scope of accommodating entrepreneurs from various industries, the Special Economic Zone (SEZ) has been deemed multi sector.

3. IIDC Kiruphema, Kohima District

NIDC was the implementation agency for setting up the Integrated Infrastructure Development Centers (IIDCs) at Kiruphema, Kohima District which was approved by the Central Government with the works been executed by the Engineering Wing of the Directorate of Industries & Commerce, Kohima. The IIDC consist of common facility centres along with developed plots. The project is still with the Directorate of Industries & Commerce Department, Kohima.

4. Refinance Schemes

Starting with a Hire Purchase Scheme in 1976-77, NIDC started employment generation assistance under the refinance schemes of the following Government organizations:

- -Industrial Development Bank of India (IDBI) since 1978.
- -National Scheduled Castes & Scheduled Tribes Finance & Development Corporation (NSTFDC) since 1992-93.
- -National Minorities Development & Finance Corporation (NMDFC) in 1997-98.
- -National Safai Karamcharis Finance & Development Corporation (NSKFDC) schemes from 2015-16.

NIDC began channeling funds of the National Scheduled Castes and Scheduled Tribes Finance Development Corporation (NSFDC) from 1992-93 and the National Minorities Development and Finance Corporation (NMDFC) since 1997-98. Further, the Corporation started implementing NSKFDC schemes in the State from 2015-16.

It is an acknowledged fact that NIDC, through its thrust in the transport sector, has created a genre of private transport operators and today there are private taxis and buses servicing every remote part of the State thereby alleviating the transport and communication bottlenecks, a crucial infrastructure for development.

Under various schemes, assistance amounting to over 16141.3 Lakhs has been disbursed to 8691 entrepreneurs and the generation of employment, both direct as well as indirect, is estimated at 19719.

The bulk of the flow of assistance was directed towards the Tiny and Small Scale Sectors including Small Road Transport Operators (SRTO).

NIDC was the implementation agency for setting up the Integrated Infrastructure Development Centers (IIDCs) at Kiruphema, Kohima District which was approved by the Central Government with the works been executed by the Engineering Wing of the Directorate of Industries & Commerce, Kohima. The IIDC consist of common facility centres along with developed plots. The project is still with the Directorate of Industries & Commerce Department, Kohima.

4. Refinance Schemes

Starting with a Hire Purchase Scheme in 1976-77, NIDC started employment generation assistance under the refinance schemes of the following Government organizations:

- -Industrial Development Bank of India (IDBI) since 1978.
- -National Scheduled Castes & Scheduled Tribes Finance & Development Corporation (NSTFDC) since 1992-93.
- -National Minorities Development & Finance Corporation (NMDFC) in 1997-98.
- -National Safai Karamcharis Finance & Development Corporation (NSKFDC) schemes from 2015-16.

NIDC began channeling funds of the National Scheduled Castes and Scheduled Tribes Finance Development Corporation (NSFDC) from 1992-93 and the National Minorities Development and Finance Corporation (NMDFC) since 1997-98. Further, the Corporation started implementing NSKFDC schemes in the State from 2015-16.

It is an acknowledged fact that NIDC, through its thrust in the transport sector, has created a genre of private transport operators and today there are private taxis and buses servicing every remote part of the State thereby alleviating the transport and communication bottlenecks, a crucial infrastructure for development.

Under various schemes, assistance amounting to over 16141.3 Lakhs has been disbursed to 8691 entrepreneurs and the generation of employment, both direct as well as indirect, is estimated at 19719.

The bulk of the flow of assistance was directed towards the Tiny and Small Scale Sectors including Small Road Transport Operators (SRTO).

The management has, in the recent years, strengthened its recovery and follow - up departments to assess the position and performance of units assisted more efficiently. Thereof, the corporation has seen a marginal increase in the rate of loan recovery performance. However, there are still obstacles in reaching the targets set. Reasons owing to willful defaulters, prevailing social and political situations, lack of adequate and timely access to working capital and similar constraints. These factors do not only affect the corporation but also the entrepreneurs who are forced to shut down or operate below capacity and unable to service the loans.

Nevertheless, efforts have been put in to regularly improve the working capacity of its recovery departments by implementing various technological solutions to assist the overall recovery performance. It may also be mentioned that the corporation is taking legal action for recovery of dues from defaulters which has produced a positive response from the defaulters. It is thus, expected that in the years to come the rate of performance in loan recovery activities will improve.

5. Residential Complex

The Residential Complex was constructed during the year 1984-85. The Residential Complex has one MIG block building consisting of 6 nos. flats, Two LIG block building consisting of 16 nos. flats and one EWS block building consisting of 10 nos. of flat. During the year 2000 additional building were constructed where one LIG block building consisting of 4 nos. of flats. Thus, all together there are 36 nos. of various types of residential flats.

NEW INITIATIVES

1. IE Tuli, Mokokchung District

NIDC has been nominated as the Implementation Agency for Infrastructure Development (ID) project vide Administrative Approval by Govt. of Nagaland on July 2017. In this respect correspondence with Directorate of Industries & Commerce, Kohima was made on August 2017 with regard to transfer of 50 acres of land at Tuli for preparation of Detailed Project Report (DPR) and other necessary formalities with respect to the project.

The ID project for a new Industrial Estate at Tuli, Mokokchung District was accorded final approval by the Ministry of MSME, Gol under Micro & Small Enterprises Cluster Development (MSE-CDP). The project is targeted to be completed by 30th June, 2024.

CONCLUSION

NIDC as a developmental agency has to depend on external funding for all its activities. The spread available from its term lending activities and other income generation like rent, commissions, etc., are only sufficient to meet administrative overheads. NIDC as a State Government undertaking is thus dependent on the State Government and other All India Financial institutions for funding its proposed programs.

While the overall economic changes in the country has attributed to the changed perceptions with regard to developmental funding, organizations like NIDC operating in economically underdeveloped states like Nagaland does suffer serious setbacks in its operations specially in the absence of fall - back supports.

However, NIDC has in the recent years been working on its new business ventures in tandem with the changing economic scenario for creating and infusing economic growth in the State. It may be stated that, NIDC as a developmental agency of the State Industries & Commerce department requires the support of the State Government by way of Equity Contributions, Grant for developmental activities, etc., for supporting and implementing new project ventures as well as for executing policies & programs of the Government in the industrial development of the State. This would further enable NIDC Ltd to establish itself as a catalyst for economic growth and development of the State.

18. STARTUP NAGALAND

INTRODUCTION

With an aim to accelerate and promote local entrepreneurs in the State of Nagaland, the Department of Industries & Commerce has been appointed as the Nodal department to implement the Start-up Policy for the state which will create an enabling environment for start-ups to grow, by ensuring knowledge exchange, capacity building, policy interventions and access to funding.

STARTUP OBJECTIVES:

- i. To facilitate the growth of startups in the State with an aim to promote at least one startup per district and establish innovative "Made in Nagaland" products and services.
- ii. Establish a State-of-the-art Innovation Hub which will serve as a technology, cultural, and creative centre where design, technology, and business shall blend to form a thriving startup community.
- iii. Mobilising funding for investment in startups through various interventions, including establishing a Fund of Funds.
- iv. Inculcate and stimulate a culture of creativity, innovation, and entrepreneurship by creating the requisite environment for learning and experimentation during all stages of education.
- v. Achieve creation of direct and indirect employment in the private sector.

Highlights of Startup Nagaland

- Since the launch of the Nagaland Startup policy 2019 Nagaland has observed the presence of innovative young minds and aspiring Startups with the sense to create and start their own Startup companies.
- The Department of Industries & Commerce being the nodal department for Startup India initiatives formed the Startup Nagaland cell to facilitate and implement activities under the State Startup Policy and Startup India in general.
- As an initiative of the State Startup policy, five incubators were recognized by the State Government to provide working space, plug-and-play facility, access to mentors, Business compliance knowledge and technology assistance. The five incubators are Youthnet Incubation Center (YIC), Edu-centre School of business (ESB), NTTC (Nagaland Tool Rooms & Training Centre), NIELIT (National Institute of Electronics & Information Technology) and NagaBots. These incubators have been instrumental in creating awareness about Startups and have considerably boosted the start-up ecosystem in the state.
- To adapt to technology advancement, evolving needs of entrepreneur and to address emerging challenges to foster a more conducive environment for innovation and growth, a new draft Start-up Policy has been submitted to the Government for amendment.

ACTIVITIES & PROGRAMMES TO BE TAKEN UP DURING 2023-24:

- 1. Startup policy Amendments: Startup Cell has compiled inputs from Stakeholders like incubators and the line departments. The draft has been submitted to administrative department for perusal and onward submission for cabinet approval.
- Policy Guidelines will also be drafted and a budget will be made in line with the start-up policy after the final approval of the policy.
- 2. The Department has signed MOU with the 5th Incubators in the State: Nagabots Incubation Centre (NAIC), the 5th Incubator under Start-Up Nagaland was inaugurated by Shri. A. Temjen Jamir, Director- Industries & Commerce, Nagaland at NAGABOTS HO, Kohima on 24th May, 2023. NAIC was inaugurated in the presence of Officers from the Department, representatives from other Incubation Centers under Start-Up Nagaland, Student Leaders, Mentors, Partners and well-wishers. Financial Support of Rs.25 lakhs is allocated to the 5th Incubator in installments for assisting Start-ups by providing plug & play facilities, R & D activities, etc.
- 3. The State was recognized as an Aspiring Leader by Department for Promotion of Industry and Internal trade (DPIIT, Ministry of Commerce & Industry in 2022 awards. Department Officers also received certificates of commendation for their contribution to strengthening the Startup ecosystem in the State.
- The state was also awarded Aspiring Leader Award by DPIIT in the recently concluded 2nd Edition of Startup Award Ceremony 2023 held at New Delhi on 16th of January 2024.
- 4. Launching of Entrepreneurship Development Centre (EDCs): The Department has also signed an MoU with YouthNet, one of the incubators, to set up Entrepreneurship Development Cells (EDC) in schools (in line with the state startup policy 2019) with an aim to nurture and promote entrepreneurship at the learning stage.
- 9 (Nine) EDCs have been established in 9 (Nine) Districts of the State namely Chumukedema, Niuland, Peren, Phek, Wokha, Mon, Longleng, Tuensang and Shamator.
- 5. MOA signing and Capacity Building for Solar Cold Storage Project: Signing of Memorandum of Agreement (MOA) and capacity building on Solar Cold Storage Project was held on 28.07.23 at IDAN office with 7 (Seven) beneficiaries from Kohima, Mokokchung, Mon, Tuensang, Peren & Wokha Districts.
- 6. Startup Green Innovation Challenge (1st Edition): NTTC in collaboration with SDGCC, Nagaland, AIC Selco and YouthNet supported by Department of Industries & Commerce, Nagaland and AIM NITI Ayog conducted a State Level Start-up Green Innovation Challenge with a total prize money award of 4 Lakhs on 16th Aug. 2023.

7. The Department has also extended financial assistance to YouthNet to conduct Cohort 2 (Orientation) & Cohort 3 (Women Entrepreneurship fellowship) for the year 2023.

Official Launching and Orientation of YIC Cohort 2 & 3: YouthNet organized the official launching and orientation of YouthNet Incubation Centre Cohort 2 at YouthNet Incubation Centre, YouthNet, Dimapur Office and Cohort 3 (Women Entrepreneurship fellowship) at Youth Net, Kohima. Each Cohort consists of 35 women startups and entrepreneurs from various sectors ranging from food processing, handloom and handicrafts, tourism, agri, logistics and others. The event was graced by Hon'ble MLA & Advisor Smti. Hekani Jakhalu, Industries & Commerce; Director of Department of Industries & Commerce, A. Temjen Jamir and Erik Azulay, Director, Alliance for Commercialization and Innovation Research (ACIR).

- 8. As part of the implementation of the Startup Nagaland policy, PwD Startup Competition was organized in collaboration with YouthNet: The competition took place at the dedicated YIC PwD Coworking Space, located at YouthNet Office Dimapur. The primary objective of this event was to encourage and empower PwD entrepreneurs, fostering an inclusive ecosystem that celebrates their talents and provides opportunities for growth. Mr. IMLI SUNEP, Founder Sunep Art emerged as the winner of the PwD Startup Competition received a sum of ₹60,000, the runner-up GMV Group receive a sum of ₹40,000/-, while the others receive a sum of ₹20,000/- each.
- 9. Setting up of Innovation & Incubation Space at Capital Convention Centre, Kohima: The Department in collaboration with the Investment Development Authority of Nagaland (IDAN) has converted an old parking lot into an Innovation and Incubation Space for Startups in the State. Engaging our own startups, an architecture firm converted the parking lot into the incubation space, swiftly furnished by a business startup. The vision is to encourage startups to occupy this space, offering it at a subsidized rent rate. IDAN, as a facilitator of investment in the state, seemed the ideal custodian for this initiative. This space will serve as a meeting ground for investors and startups, facilitating both physical and online interactions with mentors.
- 10. ASCEND Financial Literacy Bootcamp Nagaland Edition:

The ASCEND Startup Bootcamp was organized by the Department of Industries & Commerce, Government of Nagaland in collaboration with Startup India, DPIIT. The event was held on 30/01/24 at Innovation & Incubation Space, Capital Convention Centre, Kohima. The One day event brought together a diverse group of aspiring and growth-stage entrepreneurs, industry experts, and government officials.

The Department in collaboration with the Investment Development Authority of Nagaland (IDAN) has converted an old parking lot into an Innovation and Incubation Space for Startups in the State on 4th December 2023 at Capital Convention Centre, Kohima, Nagaland. This initiative was inaugurated by Dr. Chintan Vaishnav of NITI Aayog in the presence of Hon'ble MLA and Advisor of Industries & Commerce, Govt. of Nagaland.

19. ECONOMIC PLANT (EP):

Citronella essential oil is extracted from the grass and stems of Cymbopogon winterianus through Steam Distillation method. This fragrant grass got its name from the French word meaning "Lemon balm", due to its floral, citrus like aroma. Citronella oil is extensively used for a variety of purposes such as an insect repellent, anti-fungal agent, anti-bacterial, analgesic, anti-inflammatory, to treat parasitic infections, to promote wound healing, to lift mood or fight fatigue, in perfumes or as a flavour addictive in foods.

At present, there are 10 Economic Plant farms in the state namely:

- 1) Training-Cum-Production Centre, Sirhima
- 2) Mongsenyimti Farm under District Industries Centre, Mokokchung
- 3) Kubolong Farm under District Industries Centre, Mokokchung
- 4) Tsuremmen Farm under District Industries Centre, Mokokchung
- 5) Lirovimti Farm under District Industries Centre, Mokokchung
- 6) Chingmei Farm under District Industries Centre, Tuensang
- 7) Yongnyah Farm under District Industries Centre, Longleng
- 8) Leangyu Farm under District Industries Centre, Mon
- 9) Chukitong Farm under District Industries Centre, Wokha
- 10) Losami Farm under Sub-District Industries Centre, Phek

However, during the current Financial Year 2023-2024, 4 Farms did not make any production due to wear and tear of distillation machines. Altogether 199.85 litres were produced during 2023-2024 and its market value is approximately estimated around ₹ 3,00,000/- (Three lakhs) only.
