NOTIFICATION

Kohima, dated, March, 2025

NO.IDB/FV-1/2000 (Vol-II) :: In pursuance of the decision of the Cabinet in its meeting held on 9th October, 2024, the Governor of Nagaland is pleased to notify the **Nagaland Food Processing Industries Policy, 2024 (NFPIP-2024)**, which shall come into force with immediate effect.

2. The Nagaland Food Processing Industries Policy, 2024 has been formulated to promote the growth and development of the food processing sector in the State through appropriate policy interventions, including infrastructure development, investment promotion, fiscal incentives, skill development, and regulatory simplifications.
3. The Department of Industries & Commerce, Government of Nagaland, shall be the Nodal Department for the implementation, monitoring, and evaluation of the policy. A State Level Empowered Committee (SLEC) and a State Food Processing Industries Council (SFPIC) shall be constituted to oversee its implementation and review its progress from time to time.
4. The policy shall remain in force for a period of five (5) years from the date of this notification till 31/03/2030, unless otherwise extended, amended, or superseded by the Government.
5. The detailed provisions of the Nagaland Food Processing Industries Policy, 2024, are annexed to this notification and shall also be available on the official website of the Government of Nagaland (<https://industry.nagaland.gov.in/>)
